Then you do not pay VAT (in Dutch) for the solar panels, parts, and installation. You use part of the electricity generated by your solar panels yourself. What remains, you feed back to the electricity grid. If you feed more back than you use, you will receive compensation from your energy supplier.

Value Added Tax (VAT) is a consumption tax that is applied to nearly all goods and services that are bought and sold for use or consumption in the EU. The EU has standard rules on VAT, but these rules may be applied differently in each EU country.

<div class="df_qntext">How many reduced VAT rates can be applied?

One or two reduced rates may be applied to supply of specific goods and services (based on the list in Annex III of the VAT Directive), but - in most cases - not to electronically supplied services. The reduced rates mentioned here cannot be less than 5%. Some EU countries are allowed to apply special VAT rates on certain supplies.

<div class="df_qntext">What is a standard VAT rate?

Each EU country has a standard rate which applies to the supply of most goods and services. This cannot be less than 15%. One or two reduced rates may be applied to supply of specific goods and services (based on the list in Annex III of the VAT Directive), but - in most cases - not to electronically supplied services.
