What is EDF doing to support Ivory Coast's energy transition?

Renewable energy and... As part of its active involvement in supporting Ivory Coast's commitment to the energy transition, EDF is developing an innovative biomass power plant project in partnership with local energy players. Ivory Coast is aiming for an energy mix in which 42% will come from renewable energy by 2030.

Who owns the Ivory Coast electricity company?

With 4 995 employees in 2022 and 54.02% owned by Eranove, the Ivory Coast Electricity Company (CIE) is a private provider that has been linked to the Ivory Coast's government by a concession agreement since 1990.

Why did EDF sign a concession contract with the Ivorian government?

To help it achieve this goal, EDF signed a concession contract with the Ivorian government in December 2019 via BIOVEA Energie (owned with its partners Meridiam and Biokala, a subsidiary of the SIFCA group). This contract involves the design, financing, construction and operation of a 46 MW biomass power plant over 25 years.

Ivory Coast aims to increase its installed power capacity to 3.5 GW by 2025 and 8.6 GW by 2040. As part of this strategy, the country's Ministry of Mines, Petroleum and Energy signed a memorandum of understanding (MoU) with renewable energy company Kong Solaire earlier this month to construct a 50 MW solar power plant in the Tchologo region.

The largest biomass power plant in West Africa Ivory Coast is aiming for an energy mix in which 42% will come from renewable energy by 2030. To help it achieve this goal, EDF signed a concession contract with the Ivorian government in December 2019 via BIOVEA Energie (owned with its partners Meridiam and Biokala, a subsidiary of the SIFCA group).

TotalEnergies and L'Ivoirienne d'Hydroélectricité (IDH) have signed a partnership to develop a 5 MW solar photovoltaic power plant to supply IDH's production site with green energy. This project aims to install more than 8,200 photovoltaic panels, reinforcing IDH's commitment to sustainable development and the energy transition.

The Atinkou project is a 390MW gas-fired, combined-cycle power plant (CCPP) under construction in Jacquelineville, Ivory Coast. Previously known as the Ciprel V power plant, it is being developed by Atinkou, a subsidiary of French company Eranove.
