An equation for $u(x;t)$ is said to be a Korteweg-de Vries (KdV) equation (Korteweg and de Vries, 1895) if it is of the form $u_t + uu_x - \frac{1}{6}u^3 - \frac{1}{2}u^2 = E$... and to do this it is useful to see that there is a conserved energy, that is, upon multiplying by f_0 we can integrate once more: $\int (f_0)^2 + \frac{1}{6} f_3^2 + \frac{1}{2} f_2^2 = E$
