The most common forms are the following: listed at the Luxembourg Business Register. o A Public Limited Company (SA) is created through the drawing up of a notarised deed. A minimum capital of EUR30,000 has to be fully subscribed and paid up to 25% (EUR7,500) at the incorporation.

Prepare the necessary supporting documentation well in advance. Check address accuracy: before making any RCS filing, verify that Luxembourg addresses match those in the National Register of Localities and Streets. The consistency check will reduce potential delays in processing.
